Assumption of Risk, Release of Liability, Waiver of Claims

Club Getaway's administration and staff undergo extensive training and certification including but not limited to completion of an onsite ACCT (Association for Challenge Course) training. All waterfront staff have successfully completed lifeguard training by the American Red Cross and are lifeguard certified. There are, however, risks associated with participating in camp related activities.

I agree to allow my child/ward to participate in the Club Getaway Summer Camp (hereinafter Club Getaway) and affirm that my child's/ward's participation is completely voluntary. I understand that there are inherent risks including but not limited to significant bodily harm, illness, injury, or death (hereinafter inherent risks) in the activities my child will engage in at Club Getaway. I also understand that, despite safety precautions, Club Getaway cannot guarantee that my child/ward will not be injured. My child/ward and I are willing to assume these risks. To minimize the risk, I have instructed my child/ward to obey all the rules, regulations and instructions of the Club Getaway staff and administration.

In consideration for permitting my child/ward to participate in Club Getaway I voluntarily agree, for myself, my heirs, executors, and administrators, to the following:

1. TO ASSUME FULL RESPONSIBILITY FOR ANY RISKS OR LOSS, OR PERSONAL INJURY, that may be sustained by my child/ward, or any loss or damage to property owned by my child/ward, as a result of training for, participating in, or traveling to or from Club Getaway.
2. TO RELEASE, WAIVE, HOLD HARMLESS, DISCHARGE, & AGREE NOT TO SUE the person or entity responsible for administering the Club Getaway Summer Camp, or its trustees, office employees, agents, students, and staff (hereinafter referred to as "releasees") from any and all liability, claims, actions, demands, expenses, attorneys fees, breach of contract actions, breach of statutory duty, or other duty of care, warranty, strict liability actions, and causes of action whatsoever, that I might now have or may acquire in the future, arising out of the inherent risks outlined above, that may be sustained by my child, or to any property belonging to me, while training for, traveling to or from, or participating in the Club Getaway Summer Camp. This includes any claims based on the negligence of Club Getaway, its employees or agents.

Photography/Video Release

Parent/Guardian grants to Club Getaway, its representatives, and employees the right to take photographs and video of child/ward in connection with their participation in the program. Parent/Guardian also authorizes Club Getaway to copyright use, and publish the same in print and/or electronically. Parent/Guardian hereby agrees that Club Getaway may use such photographs and video of participant for any lawful purpose, including but not limited to publicity, illustration, advertising and Web content.
